MAP NOTES

This map was prepared by the Aleutian Pribilof Islands Association in cooperation with the Alaska Department of Commerce, Community and Economic Development (Commerce) using funding from the City of Atka, the Aleutian Pribilof Islands Association, Andreaf Electric, the Atka Fishermen's Association, the Atka IRA Council, the Atxam Corporation, the Aleutians West Coastal Resource Service Area, the Department of the Interior Bureau of Indian Affairs-Firewise Program, and funding from the Initiative for Accelerated Infrastructure Development (IAD). The IAD is supported by grants from the Denali Commission, USDA Rural Development, Alaska Department of Transportation and Public Utilities and Commerce. The Aleutian Pribilof Islands Association contracted with Global Positioning Services, Inc. in May of 2005 to prepare the map.

This map should not be construed as a survey. On-site surveys should be conducted prior to engineering or construction.

This map was compiled to meet horizontal and vertical accuracy in accordance with national map accuracy standards.

Property and utility information has been generated from readily available sources with limited accuracy checks. Property information is not intended to represent a title search of the Recorder's Office record. Utility location is approximate and shows only the main lines as the service lines have been omitted for clarity. Generally, the information is current as of December 2005.

The City of Atka provided sanitation facility records.

This map is based on photography acquired on May 21, 2006, at a nominal scale of 1 in = 800 ft.

Aerometric Anchorage prepared the orthophoto and topographic mapping. The orthophoto is an aerial photo which has been corrected, by rectification to ground control stations, to remove distortions and warpage due to ground topography and aircraft tilt and trim.

HORIZONTAL AND VERTICAL CONTROL
The horizontal control monument for the digital orthophoto was an NGS OPUS solution for NGS monument "BOB". The horizontal datum NAD 1983 coordinates for this monument are North 52° 12' 05.818" and West 174° 11' 46.9742". The vertical control monument was NGS monument "BOB". The Geoid 99 elevation for this monument is 193.84 feet.

This map projection is based upon NAD 83, ASP Zone 10 as expressed in US Survey Feet.

The contours were prepared at two (2) foot contour intervals with index contours every ten (10) feet.
