


Community Map WRANGELL

They also depict some of the natural features and hazards that affect the community. This information is very useful in planning for community improvements and expansion.

The Community Map shown here was prepared from an uncontrolled aerial photograph taken in 1983 by North Pacific Aerial Surveys, Inc., that was enlarged from a scale of 1" = 1,500' to 1" = 250'. The Area Map was prepared from an uncontrolled NASA photograph provided by BLM, taken in 1979 at a scale of 1" = 10,000'.
